The parties hereby irrevocably submit to the jurisdiction of any state or federal court sitting in McDowell County, North Carolina, in any action or proceeding brought to enforce or otherwise arising out of or relating to this Agreement, and hereby waive any objection to venue in any such court and any claim that such forum is an inconvenient forum.
